Sir/Madam,

In terms of section 14(1) of the NCTE Act, 1993, the above Rayappan Mriapushpam Educational & Public Charitable Trust, Plot No. D 97, Street/Road. 9th Cross, West, Thillai Nagar Village & Post, Trichy, Taluk, Tiruchiraooalli District-627414, Tamilnadu institution had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 students at Ramya Sathianathan College of Education, Plot/Khasara No. 87, Street. No. 16, Pudupatty Post & Village, Thanjavur Taluk & District-628809, Tamilnadu.

- 2. On careful consideration of original file of the institution and other related documents, the SRC in its 225th meeting held on 26th-27th June 2012 decided to issue <u>Letter of Intent</u> under sub-regulation (9) of Regulation 7 of the NCTE (Recognition Norms & Procedure), 2009 for grant of recognition to the applicant institution for <u>B.Ed</u> course of one year duration with an annual intake of 100 (one hundred only) (one basic unit) with effect from the academic session 2012-13 subject to the appointment of qualified faculty members as per policy of State Government or University Grants Commission or University before the commencement of the academic session. The institution shall ensure that the staff or faculty is appointed as National Council for Teacher Education norms within two months. The institution shall submit the list of faculty, as approved by the affiliating body, to the Regional Committee.
- 3. Further, in terms of sub-regulation (10) of Regulation 7 of the NCTE (Recognition Norms & Procedure), 2009, the institution shall launch their own website with hyperlink to National Council for Teacher Education and corresponding Regional Office website soon after the receipt of this letter covering, *inter-alia*, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure such as land, building, office, classrooms, and other facilities or amenities, instructional facilities such as laboratory, library etc. and the particulars of their proposed teaching faculty with photograph and non-teaching staff etc. with photographs, permanent account number or unique identity number of the teacher educators, whenever issued by National Council for Teacher Education, for information of all concerned. The information with regard to the following shall also be made available on the website:-
 - (a) Sanctioned programmes along with annual intake in the institution;
 - (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph:
 - (c) Name of faculty members who left or joined during the last , quarter;

- (d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f) Available infrastructural facilities;
- (g) Facilities added during the last quarter;
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The institution shall be free to post additional relevant information, if it so desires
- (ii) Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- 4. In terms of sub-regulation (11) of Regulation 7 of the NCTE (Recognition Norms & Procedure), 2009, the institution concerned, after appointing the requisite faculty or staff as per the provisions of sub-regulation (9) and after fulfilling the conditions under sub-regulation (10), shall formally inform the Southern Regional Committee, Bangalore that the faculty has been appointed as per National Council for Teacher Education norms and has been approved by its affiliating body. The letter granting approval for the Selection or appointment of faculty shall also be provided by the institution to the Regional Committee with the document establishing that the Fixed Deposit Receipt of Endowment Fund and Reserve Fund have been converted into a joint account. So that, the Southern Regional Committee may then issue a formal order of recognition which shall be notified as per provision of the National Council for Teacher Education Act.
- 5. Apart from the above, the institution is requested to submit the following also:-
 - a) Annexure I An Affidavit on Rs. 100/- stamp paper to the effect that the institution has appointed staff as per NCTE/State/University norms.
 - b) Annexure II An Affidavit on Rs. 10/- non judicial stamp paper by the individual faculty member appointed by the institution.
 - c) Annexure III Details should be filled by every faculty member appointed.
 - d) Minority Certificate issued by the Principal Secretary, Govt. of Tamilnadu to be submitted.

Format of Annexures - I, II & III are enclosed along with this letter.

6. In terms of sub-regulation (12) of Regulation 8 of the NCTE (Recognition Norms & Procedure), 2009, the University or Examining body shall grant affiliation only after issue of the formal recognition order under sub-regulation (11) of Regulation 7 of Regulations ibid. <u>Further, admissions by the institution shall be made only after affiliation by the University or Affiliating body and as per the State policy.</u>
